ALL IN THE DAY'S WORK

Believe it or not, we very frequently read the Congressional Record. Having in mind that the extra session of the Senate was for the purpose of considering a tariff bill for the relief of agriculture, we checked on the procedure.

It met at 10 o'clock in the morning and the matter up for settlement was whether the tariff on manganese should be raised from 15 thirty-second of one per cent to one per cent. No one seemed to be opposed to the raise and it was carried without a dissenting vote. But here is what the Senate did before it voted: Senator Blaine read two long letters about the South Carolina land bank. Senator Ransdell spoke for two hours giving a history of the tariff. Senator Heflin introduced a long resolution giving the Federal Farm Board instructions how to raise the price of cotton seed after discussing his resolution for more than an hour. Heflin was informed by the presiding officer that he was out of order in that the Senate could not take such action without the concurrence of the Lower House. He appealed from the ruling of the Chair and after more than an hour a discussion Heflin withdrew his appeal.

Then Senator Norris talked for 45 minutes on his motion that Senator Bingham was properly censured by a vote of the Senate three days before. Several senators then discussed the stock market, one side blaming Hoover for the crash and the other side laying the blame on Raskob. Then Senator Blaine read an article about the battle of King's Mountain fought in our war for independence. He was followed by Senator Smith who declined on the subject of machinery versus labor. Senator Wheeler then took up an hour lambasting Senator Reed for something he had said at a banquet about the western senators being no better than communists. Then Senator Blaine talked for an hour about the Bingham case. At 5:32 Senator Smoot passed for a vote on the manganese amendment and it passed unanimously. The Senate adjourned but not until Senator Smoot stated that he had carefully kept tab on proceedings for the week and that from Monday morning till Friday night, that exactly one hour and 28 minutes had been consumed on the tariff bill. Thirty-eight and one-half hours of talk and less than one hour and a half on the only question before the Senate. No wonder the Senate groaned when President Hoover said the tariff bill could be passed in two weeks.

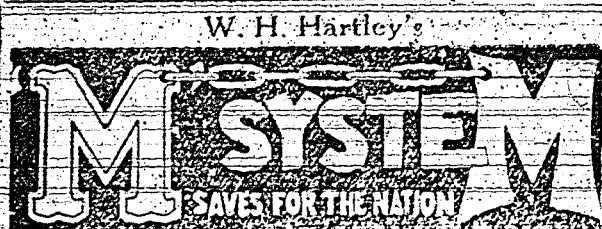

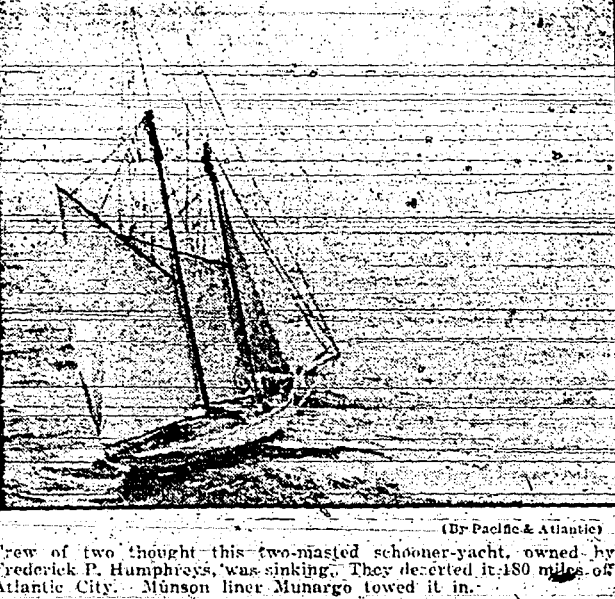
